- Large spill** :

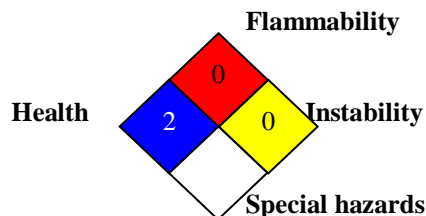
